Stottle Winery is located in Lacey, WA just north of Olympia, just minutes off I-5, we also have a tasting room in Hoodspport, WA on Hwy 101 on the Hood Canal. We are pleased to announce that our Tasting Rooms are now available for private event rentals. Stottle Winery offers space to accommodate birthday parties, anniversaries, wedding celebrations, corporate events and more – we will customize our space for you and your guests. Our Lacey Winery Tasting Room has a warm atmosphere with vaulted ceilings and beautiful locally produced artwork. This space is highly customizable and creates the perfect atmosphere for events both large and small. Our Hoodspport Tasting Room features a gorgeous natural wood bar, soft lighting, and cozy warmth with natural wood. This location is better suited for small events. ## Special Events Capacity:

### Lacey Winery Tasting Room

Guests (outside of normal business hours): 90+ for standing room only with limited seating, 45+ for seated

Guests (during business hours in our private room): 25 for standing room only, 16 seated

### Hoodspport Tasting Room

Guests (outside of normal business hours): 15 for standing room only

## Rental Pricing

Pricing varies depending on the set-up and staff requirements, size, and length of the event.

Our *minimum* facility fee for events *outside of normal hours* is \$25 and can be as high as \$500 for large events with special set-up. In addition to the facility fee, a minimum wine purchase requirement must be met by the group. The minimum wine purchase requirement can be as low as \$7 per person per hour, or as high as \$25 per person per hour depending on the size of the group, service/staff requirements, etc. The wine minimum can include wine consumed onsite during the event as well as wine purchased to take home by any guest at the event. Staff needed beyond wine related service is to be provided by a caterer.



For small private events and gatherings *during business hours* there is no facility fee if no special set-up is required. We only require a minimum wine purchase of \$9 per person per hour, 6 person minimum, 20 maximum. We do require a deposit for groups larger than 10 people. Please note, we do not waive tasting fees when using our private room, or at private after hours events.

The above prices are to give you a general idea. We'd like to tailor the experience to your needs and can include guided tastings, tours, etc. and offer custom pricing to meet your requirements and budget.

Stottle Wine Club members receive special pricing for use of our space. Please let us know if you are a club member when inquiring about your event.

For groups who wish to use the space for meetings where wine may not be consumed (and therefore no need for a server to be present), we offer an option without a minimum purchase requirement, of \$50 per hour for groups up to 10 people, and \$75 for groups up to 16. This is available Wed – Sun only, with the meeting ending by 6pm and starting no earlier than 9am. There is an additional cleaning fee of \$25 for catered events. Call for pricing for larger groups.

For charitable non-profits wishing to use the space for a fund raising or other event, we offer special pricing and options to help make your event a success. Please contact us to discuss options.

## **Deposits and Cancellation**

All special events at our tasting rooms require a 25% or \$25 (whichever is larger) deposit at the time of reservation for groups larger than 10 or groups requiring a cheese plate or other special requests. If your event is cancelled 7 or more days in advance, we will refund your entire deposit less a \$10 processing fee. If your event is cancelled between 3 and 7 days in advance, we will refund your entire deposit less a \$25 cancellation fee and any direct cost of food or item purchased specifically for your event. Less than a 3 day advance notice of cancellation may result in forfeiture of the advanced deposit. Refunds will not be provided due to inclement weather or rain, but will be considered in extreme situations of snow and/or ice.

## **Decor**

If your needs extend beyond what we have available, we are happy to assist with event rentals (chairs, tables, linens, silver wear, etc.). We wish for you to have a festive atmosphere for your event, but we do not allow the use of confetti, open flames, glitter or anything else that may result in damage to the facility.

## **Food and Wine Service**

Only Stottle wines are allowed at your event and must be purchased through the winery. All wine is served in crystal stemware. Beer, Champagne, hard alcohol, or any other alcoholic beverage are prohibited by law in our facility and may result in a penalty if brought in. You are welcome to bring in



your own non-alcoholic beverages. An 18% gratuity will be added to the cost of wine served during the event. We require any onsite food be provided by a licensed caterer or bought pre-prepared from a restaurant or grocery store, please no homemade food. Any food service contract is to be established between the renter and caterer.

## **Miscellaneous**

Children are welcome but supervision is the sole responsibility of the renter and/or their guests. Entertainment is allowed at events held outside of our normal hours, whether it is live music or through the use of our stereo system. Audio/Visual equipment would need to be provided by the renter.

## **Parking**

There is ample parking for nearly any size event at our Lacey Winery Tasting Room. There is additional parking in the rear of our Hoodsport tasting room to accommodate the maximum group size at that location.
